- We have raised \$5.63M toward the \$7.5M capital campaign goal more than 75%! The community rose to meet the 1:1 challenge from The Kenan Charitable Trust of \$450,000.
- 14 business leaders formed a new Corporate Committee and are helping to engage the business community in the campaign.
- Campaign donors are responding to the urgent need for affordable homeownership in Chapel Hill and to Habitat's innovative approach to building a diverse community.
